Stay - Costs - motion seeking stay of costs assessment of court below until appeal decided - appellants sought respondents' consent to orders before filing motion - respondents agreed to orders on morning of hearing - whether to grant stay - whether respondents should pay appellants costs of notice of motion on indemnity basis - requirement that parties and legal representatives assist court in pursuit of objectives of s56 *Civil Procedure Act* 2005 (NSW).
