QAD Inc v Shepparton Partners Collective Operations Pty Ltd (FCA) - copyright - licence agreement - applicants ('QAD') contended infringement by respondent (SPC) of copyright in their software - QAD's claim established - SPC's cross-claim dismissed (IB)

Ferdinands v Registrar Cridland (FCA) - judicial review - applicant sought review of respondent's refusal to accept 'proposed originating application and supporting documents' 'for filing' - no error in Registrar's decision - judicial review application dismissed (I B C G)

Seeley International Pty Ltd v Millennium Electronics Pty Ltd (In Liq) (No 3) (SASC) - consumer law - contract - negligence - applicant claimed for losses allegedly sustained due to

respondent's failure to supply to applicant 'a properly working electrical element' - judgment for applicant in sum of \$13,277,000.00 (I B C G)

QAD Inc v Shepparton Partners Collective Operations Pty Ltd [2021] FCA 615

Federal Court of Australia

Thawley J

Copyright - licence agreement - applicants ('QAD') contended infringement by respondent (SPC) of copyright in their software - SPC was continuing to use QAD's software after resits purchase of business from respondent (SaleCo) - QAD's software used by SPC without transfer of 'relevant software licence agreement' - SPC did not pay fee required by QAD as condition of 'consent to transfer the licence' - SPC contended it had 'implied licence' to use software - SPC cross-claimed including on basis that, contrary to contract of sale's requirement, SaleCo had 'failed to use "best endeavours" in secure licence agreement's transfer - held: QAD's claim established - SPC's cross-claim failed.

Federal Court of Australia

White J

Judicial review - applicant sought review of respondent's refusal to accept 'proposed originating application and supporting documents' 'for filing' - r2.26 Federal Court Rules 2011 (Cth) - Ferdinands v Registrar Parkyn [2020] FCA 1676 - Nyoni v Murphy [2018] FCAFC 75 - whether applicant's documents were "frivolous" and "vexatious" - held: no error in Registrar's refusal to accept documents for filing - judicial review application dismissed.

Corporations - winding up - plaintiffs sought order under s588FF(1)(a) Corporations Act 2001 (Cth) (Corporations Act) requiring defendant to pay amount to Company on basis 'tax payments' were voidable transactions under 588FE Corporations Act - whether 'unfair preference transactions' under s588FA Corporations Act which occurred when Company insolvent: s588FC(1)(a) Corporations Act - 'insolvency issue' - 'preference issue' - held: proceedings dismissed.

Kralcopic v Minister for Resources (No 2) [2021] VSC 258

Supreme Court of Victoria

Judicial review - corporations - defendant's delegate refused to renew mining licences of plaintiff ('refusal decision') - plaintiff placed into liquidation by order for winding up - defendant sought declaration that plant left on land to which licences had applied 'was forfeited to the Crown' from date six months subsequent to refusal decision - whether to grant leave to proceed - s471B Corporations Act 2001 (Cth) - s114 Mineral Resources (Sustainable Development) Act 1990 (Vic) - held: declaration granted - proceeding otherwise dismissed.

<u>Seeley International Pty Ltd v Millennium Electronics Pty Ltd (In Liq) (No 3)</u> [2021] SASC 63

Supreme Court of South Australia Justice Livesey

Consumer law - contract - negligence - applicant claimed for losses allegedly sustained due to respondent's failure to supply to applicant 'a properly working electrical element' - applicant contended that the element's 'defective design' had caused 'faulty operation' of heaters over 'period of some two years' - whether breach of 'express and implied terms' of contract - whether 'negligent breach of duty' - whether contributory negligence - whether contravention of Australian Consumer Law - whether misleading and deceptive conduct - held: judgment for applicant in sum of \$13,277,000.00.
