Frugtniet v Australian Securities and Investments Commission (HCA) - administrative law - criminal law - Administrative Appeals Tribunal, on review of respondent's decision to impose a 'banning order', could not take into account appellant's 'spent convictions' - appeal allowed (I B C G)

Degroma Trading Inc v Viva Energy Australia Pty Ltd (FCA) - arbitration - application under s7(2) *International Arbitration Act 1974* (Cth) for stay of proceeding and transfer of dispute to arbitration - application granted (I B C G)

Keyzer v La Trobe University (FCA) - employment - interveners sought 'suppression or non-publication order' concerning their names and complaints - application refused (B C I G)

In the matter of Electrical Energy Pty Limited (NSWSC) - corporations - statutory demand - company sought to set aside statutory demand served on it by Deputy Commissioner of Taxation - originating process dismissed (B C I G)

Hackett v State of South Australia (VSC) - cross-vesting - plaintiff injured at wildlife park in South Australia commenced proceedings in Bendigo, Victoria - defendant sought transfer of proceedings to South Australia - application granted (I B C G)

- consumer law - 'written Land Sale Agreement' - breach of warranty - misleading or deceptive conduct - judgment for plaintiff (I B C G)

IVO Nominees Pty Ltd v Shire of Murray (WASC) - planning and development - criminal law appellant convicted of two offences under s218 Planning and Development Act 2005 (WA) leave to appeal granted - appeal allowed (I B C G)

Frugtniet v Australian Securities and Investments Commission [2019] HCA 16

High Court of Australia

Kiefel CJ; Bell, Gageler, Keane, Nettle, Gordon & Edelman JJ

Administrative law - criminal law - respondent made 'banning order' against appellant respondent, in making banning order, could not take into account appellant's 'spent convictions' under Pt VIIC Crimes Act 1914 (Cth) (Crimes Act) - appeal concerned question whether Administrative Appeals Tribunal (AAT), on review of respondent's decision to impose banning order, could take into account the spent convictions - statutory construction - whether AAT's 'decision-making power', in exercising jurisdiction conferred by s327 National Consumer Credit Protection Act 2009 (Cth) & ss25 & 43 Administrative Appeals Tribunal Act 1975 (Cth), was constrained by Pt VIIC Crimes Act - held: Court answered question in the negative - AAT not entitled to take into account spent convictions - appeal allowed.

Degroma Trading Inc v Viva Energy Australia Pty Ltd [2019] FCA 649

Federal Court of Australia

O'Callaghan J

Arbitration - applicant, pursuant to s7(2) International Arbitration Act 1974 (Cth), sought stay of respondent's proceeding against it and transfer of dispute to arbitration - applicant contended parties 'concluded an arbitration agreement' under which disputes were to be resolved by 'London arbitration' at either party's election - applicant contended it had made election 'by notice to' respondent - respondent denied there was 'valid arbitration agreement' and contended entitlement to bring claims in Court - principles in Hancock v Rinehart (2017) 257 FCR 442 -'doctrine of separability' - held: Court satisfied to stay proceeding and remit matter to arbitrator. Degroma (IBCG)

Keyzer v La Trobe University [2019] FCA 646

Federal Court of Australia

Anastassiou J

Employment - 'suppression or non-publication order' - applicant's employment suspended by respondent pending its investigation into 'alleged misconduct' by applicant - investigation arose from complaints by interveners - interveners sought suppression or non-publication order as to their identities and 'material which would tend to reveal' complaints' nature - Court had made interim suppression order - whether to extend the interim suppression order further - whether necessary to grant interveners leave to intervene - whether to grant leave to intervene - r9.12 Federal Court of Australia Rules 2011 (Cth) - 37AG(1)(a) Federal Court of Australia Act 1976 (Cth) - whether interveners' 'legitimate personal interest' in maintaining privacy sufficient for conclusion that their interests' protection was 'necessary to prevent prejudice to the administration of justice' - held: application refused.

In the matter of Electrical Energy Pty Limited [2019] NSWSC 547

Supreme Court of New South Wales

Rees J

Corporations - statutory demand - plaintiff company (Electrical Energy Pty Limited), under s459G *Corporations Act 2001* (Cth), sought to set aside statutory demand which Deputy Commissioner of Taxation served on it - plaintiff contended the demand did not take into account payment which plaintiff made 'at or about the time' of issue of demand - whether amount which debtor paid and which was accepted by creditor was "offsetting claim" or gave rise to defect such that Court should set demand aside - held: originating process dismissed. View Decision (B C I G)

Hackett v State of South Australia [2019] VSC 311

Supreme Court of Victoria

Daly AsJ

Cross-vesting - plaintiff lived in Bendigo, Victoria - plaintiff injured at wildlife park in South Australia - plaintiff commenced proceedings in Bendigo - defendant, under s5 *Jurisdiction of Courts (Cross-vesting) Act 1987* (Vic), sought transfer of proceedings to South Australia - interests of justice - held: Court satisfied Supreme Court of South Australia was 'more appropriate forum' for proceeding's 'conduct and hearing' - application granted.

Peters Properties Maddington Pty Ltd v Keen [2019] WASC 138

Supreme Court of Western Australia

Allanson J

Contract - planning and environment - consumer law - plaintiff and defendants entered 'written Land Sale Agreement' (agreement) in which plaintiff purchased land from defendants - plaintiff contended defendants breached warranties in agreement by failure to disclose 'Development Approval' conditions on land's use and failure to disclose land's use was unlawful - plaintiff also claimed misleading or deceptive conduct by defendants concerning land's sale before agreement and in between agreement's date and settlement - *Planning and Development Act 2005* (WA) - *Town Planning and Development Act 1928* (WA) - 'environmental buffer' - held: plaintiff established breach of warranty and misleading or deceptive conduct - judgment for plaintiff including costs of complying with Development Approval.

IVO Nominees Pty Ltd v Shire of Murray [2019] WASC 67

Supreme Court of Western Australia

Curthoys J

Planning and development - criminal law - appellant convicted by Magistrate of two offences under s218 *Planning and Development Act 2005* (WA) - appellant sought to appeal - appellant contended Magistrate erroneously found activities required development approval and erred in conclusion concerning extent of appellant's 'non-conforming use rights' - appellant alternatively contended sentence excessive - whether appeal grounds had 'reasonable prospect of success' - land clearing - 'drain excavation' - cl8.1(i) Shire of Murray Town Planning Scheme No 4 - held: leave to appeal granted - appeal allowed.
