Negligence - road authorities - s45(1) *Civil Liability Act* 2002 (NSW) - actual knowledge - defendant driver of a prime mover & attached trailer which collided with and caused damage to Armco guardrail located on side of roadway - vehicle was damaged in the accident - in the Local Court plaintiff RTA commenced proceedings seeking damages for costs of repair to a guardrail - defendant had defended the proceedings & cross-claimed against RTA alleging negligence - magistrate ordered verdict for RTA & verdict for defendant on the cross-claim - *Law Reform* (*Miscellaneous Provisions*) *Act* 1946 (NSW) - error of law in so far as the Magistrate made an order for contribution - appeal allowed in part.
