Palmer v State of Western Australia (No 3) (FCA) - withdrawal of intervention - part of High Court proceedings remitted to Federal Court of Australia - Commonwealth did not require 'leave to withdraw or discontinue' intervention - rehearing refused (B C I G)

Withdrawal of intervention - applicants commenced proceedings in High Court of Australia (High Court proceedings) - Attorney-General of the Commonwealth of Australia (Commonwealth) intervened - part of High Court proceedings remitted by High Court to Federal Court of Australia - Commonwealth notified High Court and Federal Court of withdrawal of its intervention - respondents contended Commonwealth required 'leave to withdraw' - respondents also contended 'leave should only be granted on particular terms' - prejudice - whether to order 'further rehearing of the evidence' - held: Commonwealth did not require 'leave to withdraw or discontinue' - rehearing refused.

Burley J

Trade mark - consumer law - service - applicant sought orders for 'short service of originating process and affidavits', service out of jurisdiction, and substituted service orders on respondent - s120 *Trade Marks Act 1995* (Cth) - s18 Australian Consumer Law - rr1.39, 10.24, 10.42 & 10.43(2) *Federal Court Rules 2011* (Cth) - held: orders granted.

Preliminary discovery - service - defamation - prospective applicant sought to serve 'originating application and accompanying documents' on respondent in United States of America and orders for preliminary discovery against respondent - Pt 10 Federal Court Rules 2011 (Cth) (Rules) - whether appropriate to make 'substituted service order' under r10.24 Rules - COVID-19 - whether 'prima facie case for preliminary discovery' under r7.22 Rules - held: leave to serve originating application and accompanying documents granted under rr10.42, 10.43 & 10.44 Rules - email service 'conditional on, and will not be effective until' respondent's 'acknowledgment of receipt'. Kukulka (B C I G)



Molony v Sydney Local Health District [2020] NSWSC 1050

Supreme Court of New South Wales

Harrison J

Approval of settlement - medical negligence - infant plaintiff, by tutor, contended that her 'injuries and disabilities' resulted from defendant's failure 'to ensure that she was delivered in a timely way, and earlier than she was' - parties agreed on settlement of proceedings - whether to approve settlement - best interests of plaintiff - held: Court satisfied that settlement was in plaintiff's best interests - settlement approved.

Dodd v Dodd [2020] NSWSC 1094

Supreme Court of New South Wales

Davies J

Pleadings - possession - wills and estates - succession - deceased was registered proprietor of land - plaintiff sole beneficiary of estate of deceased sought land's possession - son of deceased was in occupation of property - defendant filed 'document described as a defence' - whether claim under *Succession Act 2006* (NSW) amounted to defence to possession claim - held: defendant's defence struck out - plaintiff granted leave 'to move for default judgment' and 'issue writ of possession'.

Supreme Court of South Australia

Doyle J

Judicial review - summary dismissal - delegate of Chief Executive of the Department of Correctional Services refused applicant prisoner's request to be transferred to 'Adelaide Pre-Release Centre' - applicant sought judicial review - respondent sought summary dismissal of applicant's claim on basis review grounds lacked merit and 'unavailability of the relief sought' - whether 'misapprehension of obligations' under s23 *Correctional Services Act 1982* (SA) - whether 'failure to afford procedural fairness' - whether failure to take relevant considerations into account - whether reasonable basis for relief sought - held: action summarily dismissed under r256.5 *Uniform Civil Rules 2020* (SA).

Hilev J

Costs - plaintiff unsuccessful 'against all of the defendants' - 'third, fourth and fifth defendants' sought costs on indemnity basis - whether to award costs on indemnity basis - *Laminex Group Pty Ltd v Catford (Costs)* [2019] NTSC 3 - "sitting on its rights" - non-compliance with Practice Direction 6 of 2009 - 'commencing and continuing hopeless claims' - 'allegations of fraud and



misconduct' - 'particular misconduct causing loss of time to the Court and or the parties' - held: indemnity costs order refused.
