Taxation - trusts - appeal from decision of Commissioner of Taxation disallowing objection against amended assessment - applicant trustee of complying superannuation fund - trust income applied to superannuation fund pursuant to trust instrument - applicant's onus to prove amended assessment excessive - whether distribution to applicant from trust gives rise to *special income* under s273 *Income Tax Assessment Act* 1936 (Cth) (Act) - concept of *income derived* in s273(6) of the Act - whether applicant's net capital gain was *income derived* - principle that statutory income including net capital gain forms part of assessable income: *Federal Commissioner of Taxation v Bamford* [2010] HCA 10.

Recovery of costs - unpaid barrister's fees - appeal from decision dismissing application that respondents' defence and cross-claim be struck out pursuant to r14.28 *Uniform Civil Procedure Rules* 2005 (NSW) (**Rules**) - applicant barrister sought unpaid fees from respondent solicitors - respondents sought but were refused assessment of memorandum of fees under the *Legal Profession Act* 2004 (NSW) (**Act**) due to expiry of time-limit under the Act - circumstances in which leave will be granted to argue previous Court of Appeal decision was wrongly decided: *Gett v Tabet* [2009] NSWCA 76 - circumstances and manner in which barristers entitled to sue for their fees - whether Div11 of the Act provided an exclusive regime for assessing reasonableness of costs - whether court had jurisdiction to determine reasonableness of disputed items in a bill of costs - principles for exercise of jurisdiction under r14.28 of the Rules.

Contract - operation agreement for maintenance of plant and equipment services -action for breach of agreement in relation to applicant's refusal to make any further payments for maintenance - applicant sought stay of proceedings until there had been compliance with dispute resolution procedure (**DRP**) contained in contract - court's power to stay proceedings - no basis in principle for treating DRP any differently from arbitration clause or expert determination clause: *Dobbs v National Bank of Australasia Ltd* (1935) 53 CLR 643 - burden on parties to an application for stay of proceedings: *Zeke Services Pty Ltd v Traffic Technologies Ltd* [2005] 2 Qd R 563 - whether DRP unenforceable to due uncertainty or futility - whether demonstration of pointlessness in continuing dispute resolution process.

Procedure - self-represented plaintiff - defendant sought dismissal of proceedings under court's inherent jurisdiction or r658 *Uniform Civil Procedure Rules* 1999 (Qld) (**Rules**) or alternatively that proceedings be stayed - plaintiff commenced proceedings in Magistrates Court - matter transferred to Supreme Court on basis of public interest - plaintiff's claim struck out - plaintiff failed to comply with court orders - court's power to terminate proceedings for abuse of process: *von Risefer & Ors v Permanent Trustee Co Pty Ltd & Ors* [2005] QCA 109 - requirements of prompt and orderly progress of litigation: r5 of the Rules - public interest in expeditious resolution of litigation - whether to fix costs of proceedings commenced by plaintiff - court's power to fix costs: r687(2)(c) of the Rules - whether costs should be assessed in accordance with scale of costs and charges applicable in Magistrates Court.

Discovery - plaintiff sought declaration that defendant had persistently instituted vexatious proceedings pursuant to s39 *Supreme Court Act* 1935 (SA) - defendant sought production of documents by plaintiff pursuant to r215(1)(c) *Supreme Court Civil Rules* 2006 (SA) (**Rules**) - plaintiff resisted production on basis of legal profession privilege pursuant to r140(6) of the Rules - whether documents *prima facie* subject to legal professional privilege - principles applicable to communications between opposing parties and communications between solicitor and client - whether *prima facie* privilege abrogated due to creation for unlawful or improper purpose: *Commissioner of Australian Federal Police v Propend Finance Pty Ltd* [1996] HCA 3.

Supreme Court of South Australia

Blue J

Contract - conveyancing - contract between plaintiff and first defendant acting as agent for second defendant to sell property after first defendant exercised option - option agreement required plaintiff to serve vendor's statement pursuant to s7 *Land and Business (Sale and Conveyance) Act* 1994 (SA) - first defendant rescinded contract for misrepresentation because property contained asbestos - plaintiff terminated contract for breach and/or repudiation and claimed damages for loss of bargain - defendant counterclaimed for return of deposit - contractual construction - *whether:* term of contract that plaintiff serve accurate vendor's statement; statement required to disclose asbestos; term rendered void by s33 of the Act; obligation to settle postponed by s7 of the Act in absence of receipt of complying vendor's statement; breach of implied term requiring cooperation; unconscionable conduct by plaintiff; defendant ready willing and able to settle; plaintiff ready willing and able to comply with obligation to serve complying vendor's statement; plaintiff's breach precluded termination or claim for loss and damages; first defendant's conduct dispensed with further performance of vendor's statement obligation.
